Call to Order

Approval of April Meeting Minutes

Motion made by Burke and second by Dorvillier to approve minutes from the monthly BOD meeting on April 13, 2016. Motion passed with 8 Ayes and 0 Nayes with abstentions from Arredondo, Fazzio and Walker.

President's Report

CA commented about the success of the La Jolla Padres game

PROW/PDO Process Update-PROW removed from CPA agenda, delayed until next month, LIVMA needs to address the A-Frame sign issue in the village, we need a "standard" regulation for the village. We need enforcement from the city, the recommendation needs to go to city council for a formal amendment to the PROW. Currently, La Jolla has a NO A-Frame signs in the PROW law but it is not being enforced. The LIVMA would prefer to have a standardized law that allows for signs with fees within reason similar to the rest of the communities in San Diego.

The Cove Solutions Update-La Jolla town council will be having another meeting. Mayor Faulkner has a team of reps from the hotels, restaurants, Ray Ellis, chief of police and lifeguards, CA Marengo. The Mayor realizes that spraying is only good for a few days and the sea lions are becoming emaciated which is contributing to the stench. CA announced that it is okay for the sea lions to be on the beach as there are legal means to remove them. It's the rocks with the runoff that is tougher due to the necessity for legal remedies. We are still hoping the rollers will be installed at the base of the rocks sooner rather than later.

City of SD- Code monitoring team-the FEDS and FCC are loosening regulations for cell towers & antennaes & they have control not the local code monitoring teams. The code monitoring teams are trying to insert language that will offer a compromise with the FCC. The community groups are not happy with the city of San Diego's lack of control

Affordable Housing density bonus-will be heard on 6/24, the bonuses will not affect La Jolla that much

Promotions Division Report

San Diego Bay Fest at Scripps Park September 16-18, Event Support

David Payne-with RTE productions, formerly did the SD Jazz festival, wants to start a LJ Jazz festival at Scripps Park with about 2,500 attendees, vendors on one side of the park, stage and concert on the other with tented areas and VIP tents. The City of SD gave their temporary approval, pending approval by the La Jolla organizations, the City is concerned about traffic and the condition of the grass, shooting for October or possibly Spring of 2017. All seats are reserved. They are proposing off-site parking. Marengo expressed concern regarding overflow trash into the Village as the City doesn't pick up the trash until Monday. Fazzio suggested merging the event with the holidays

Economic Development Division

Business development report-

Arredondo-The committee is continuing to work on both long and short term goals. Their biggest concern is the empty storefronts. They are focusing on Fay first. The long term plan is to conduct another survey to ask the locals/residents what kinds of businesses they want to have in the Village. They want to create districts such as the "Entertainment" or "Cultural" district, the "Financial" district, etc. They have a data base of the landlords. Fortune joined ICSC (shopping centers) and stated that the majority of the property owners are trusts or foreign and don't have an emotional connection to the Village. Marengo wants to have good communication with the commercial brokers so they can hopefully encourage specific tenants/uses for the vacant spaces. Dorvillier suggested "skinning" the windows of the vacancies with upcoming events or suggested uses but Arredondo said they are not tackling that at this time.
